加拿大禁用多溴联苯醚 (PBDEs)

加拿大政府最近公布了多溴联苯醚(Polybrominated Diphenyl Ethers - PBDE)法规,该法规将并入加拿大环境保护法(Canadian Environmental Protection Act, 1999)。

新法规定,从 2008年6月19日起,

任何人不得生产分子式为 $C_{12}H_{(10-n)}Br_nO($ 其中 $4 \le n \le 10)$ 的任何多溴联苯醚,也不得生产、使用、销售、提供或进口含有以下多溴联苯醚的多溴联苯醚、树脂、聚合物或其它混合物:

- 1. 四溴联苯醚 (分子式为C₁₂H₆Br₄O)
- 2. 五溴联苯醚 (分子式为C₁₂H₅Br₅O)
- 3. 六溴联苯醚 (分子式为C₁₂H₄Br₆O)

PBDE 法规的豁免项目包括:

- (1) 有害物控制产品管理法(Pest Control Products Act)中包含的多溴联苯醚。
- (2) 以下三种用途的多溴联苯醚: (a) 实验室分析用途; (b) 科学研究目的; (c) 作为实验室分析的标准物质。
- (3) 被制造成特定的物理形状,且其物理形状或设计决定最终用途。
- (4) 化学反应原料中作为污染物存在的、且不会释散的多溴联苯醚,并且在反应完成后会完全消失或转换成其它物质。

此外,各类多溴联苯醚的检测必需经由 ISO/IEC 17025: 2005 认可的实验室执行,并且实验室的测试范围内应包括多溴联苯醚的分析。

Polybrominated Diphenyl Ethers(PBDEs) Regulations in Canada

The Canada Government has recently published the Polybrominated Diphenyl Ethers (PBDEs) Regulations under the Canadian Environmental Protection Act, 1999 (CEPA 1999).

With effect from June 19, 2008:

No person shall manufacture any PBDE that has the molecular formula $C_{12}H_{(10-n)}Br_nO$ in which $4 \le n \le 10$, or manufacture, use, sell, and offer for sell or import a PBDE, or any resin, polymer or other mixture containing a PBDE set out as follows:

- Benzene, 1,1'-oxybis-, tetrabromo derivative that has the molecular formula C₁₂H₆Br₄O (tetraBDE)
- Benzene, 1,1'-oxybis-, pentabromo derivative that has the molecular formula C₁₂H₅Br₅O (pentaBDE)
- Benzene, 1,1'-oxybis-, hexabromo derivative that has the molecular formula C₁₂H₄Br₆O (hexaBDE)

The applied exceptions are as below:

- (1) Any PBDE which is contained in the Pest Control Products Act.
- (2) Any PBDE which is for use(a) in a laboratory for analysis; (b) in scientific research; or (c) as a laboratory analytical standard.
- (3) Any PBDE which is formed into a specific physical shape, and has a final use dependent on its shape or design.
- (4) Any PBDE which presents as contaminant in a chemical feedstock and there are no releases of PBDE, provided that the PBDEs are all destroyed or completely converted into other substances.

Furthermore, the presence of any PBDE shall be determined by a laboratory that is accredited under the standard ISO/IEC 17025: 2005, and whose accreditation includes the analysis of PBDEs within its scope of testing.
