1、Brazil – Draft Amendments to Mandatory Safety Requirements for Children’s Strollers (Apr 9,2015)

The National Institute of Metrology, Standardization and Industrial Quality (INMETRO) of Brazil has published Portaria No.145/2015 to propose draft amendments to the Quality Technical Regulation for Children’s Strollers (Portaria No.315/2012). If approved as proposed, the amendments shall enter into force on its publication date in the Official Gazette. The major proposed changes are highlighted as follows:

2、Ecuador - Proposed Draft Technical Regulation for Self-Adhesive Tape for General Use. (Apr 9,2015)

厄瓜多尔-对民用自粘性胶带技术规范的提议草案 (2015年3月4日)

The Ministry of Industry and Productivity of Ecuador (MIPRO) has proposed the draft Ecuadorian Technical Regulation "Self-adhesive tape for general use" (PRTE INEN 265). If approved as proposed, this Technical Regulation shall enter into force after 180 calendar days from the date of its promulgation in the Official Gazette. Here are highlights of the proposed regulation:

厄瓜多尔工业生产部 (MIPRO) 已提议关于“民用自粘性胶带”的技术规范草案 (PRTE INEN 265), 如草案获得同意, 经官方公告180个自然日后, 此技术规范将被予以执行。

Scope\范围

This technical regulation applies to the following types of imported and domestically manufactured self-adhesive tape for general use marketed in Ecuador:

- Pressure-sensitive self-adhesive film, paper and cloth tapes used for packaging, closing and sealing boxes.
- Pressure-sensitive self-adhesive paper tape used for light packaging and sealing in general.
- Pressure-sensitive self-adhesive tape used for closing and sealing containers with sliding covers, such as fibre tubes and metal cans.

3、Canada - Proposes Regulations Amending the Prohibition of Certain Toxic Substances Regulations. (Apr 10,2015)

加拿大-提出禁用一些有毒有害物质的修订法规 (2015年4月10日)

The proposed Regulations Amending the Prohibition of Certain Toxic Substances Regulations, were published in the Canada Gazette on 4 April 2015 in order to amend the Prohibition of Certain Toxic Substances Regulations. The proposed Regulations propose to prohibit the manufacture, use, sale, offer for sale, or import of the following 5 additional toxic substances and products containing these substances, with some exemptions:

1. Hexabromocyclododecane (HBCD)
2. Perfluorooctanoic acid, its salts, and its precursors (PFOA)
3. Long-chain perfluorocarboxylic acids, their salts, and their precursors (LC-PFCAs)
4. Polybrominated diphenyl ethers (PBDEs)
5. Perfluorooctane sulfonate (PFOS)

1. 六溴环十二烷
2. 全氟辛酸铵, 其盐类及其产物
3. 长链全氟羧酸, 其盐类及其产物
4. 多溴联苯醚
5. 全氟辛烷磺酰基化合物

4、Ecuador - Proposed Draft Technical Regulation for Table-tennis Tables. (Apr 10,2015)

厄瓜多尔-提议起草乒乓球桌的技术规范 (2015年4月10日)

If approved as proposed, these proposed Regulations shall come into force on the day that is 3 months after the day on which they are registered. There will be some transitional provisions and the following existing Regulations will be repealed:

1. Polybrominated Diphenyl Ethers Regulations
2. Perfluorooctane Sulfonate and its Salts and Certain Other Compounds Regulations

The Ministry of Industry and Productivity of Ecuador (MIPRO) has proposed the draft Ecuadorian Technical Regulation "Table-tennis tables" (PRTE INEN 279). If approved as proposed, this Technical Regulation shall enter into force after 180 calendar days from the date of its promulgation in the Official Gazette.

Scope\范围

This Technical Regulation applies to table-tennis tables, hereinafter referred tables, which are marketed in Ecuador, imported or domestically produced.

5、EEU – European Commission added exemptions to RoHS 2 (Apr 13,2015)

EU-欧盟委员会对ROHS2新增豁免 (2015年4月13日)

Directives were published to add more exemptions from the restriction of the use of lead, mercury, cadmium, hexavalent chromium, PBB & PBDE in electrical and electronic equipment (EEE) to the Annexes III & IV in Directive 2011/65/EU (RoHS 2). Here are the highlights:

指令公布在2011/65/EU(ROHS2)指令附录III & IV中对电子电器产品中铅、汞、镉、六价铬, 多溴联苯和多溴联苯醚的限制所新增的豁免。如下:

Annex III - Applications exempted from the restriction in Article 4(1):

1. 2014/76/EU: Mercury in hand crafted luminous discharge tubes used for signs, decorative or architectural and specialist lighting and light-artwork.
2. 2014/72/EU: Lead in solders and termination finishes of electrical and electronic components and finishes of printed circuit boards used in ignition modules and other electrical and electronic engine control systems, which for technical reasons must be mounted directly on or in the crankcase or cylinder of hand-held combustion engines

附录III -条款4 (1) 中的豁免应用 :

1. 2014/76/EU: 用于标牌、装饰或建筑和专业照明和灯光艺术品中手工制作的发光放电管中的汞。
2. 2014/72/EU: 用于点火模块和其他电子电气发动机控制系统中使用的电子电气元件的焊料及终端处理和PCB的表面处理中的铅。

Annex IV - Applications exempted from the restriction in Article 4(1) specific to medical devices and monitoring and control instruments:

1. 2014/75/EU: Mercury in cold cathode fluorescent lamps for back-lighting liquid crystal displays, not exceeding 5 mg per lamp, used in industrial monitoring and control instruments placed on the market before 22 July 2017
2. 2014/74/EU: Lead used in other than C-press compliant pin connector systems for industrial monitoring and control instruments
3. 2014/73/EU: Lead in platinized platinum electrodes used for conductivity measurements where at least one of the specified conditions applies
4. 2014/71/EU: Lead in solder in one interface of large area stacked die elements with more than 500 interconnects per interface which are used in X-ray detectors of computed tomography and X-ray systems
5. 2014/70/EU: Lead in micro-channel plates (MCPs) used in equipment where at least one of the specified properties is present
6. 2014/69/EU: Lead in dielectric ceramic in capacitors for a rated voltage of less than 125 V AC or 250 V DC for industrial monitoring and control instruments
7. 2015/573/EU: Lead as a thermal stabiliser in polyvinyl chloride (PVC) used as base material in amperometric, potentiometric and conductometric electrochemical sensors which are used in in-vitro diagnostic medical devices for the analysis of blood and other body fluids and body gases
8. 2015/574/EU: Mercury in electric rotating connectors used in intravascular ultrasound imaging systems capable of high operating frequency (> 50 MHz) modes of operation

8. 2015/574/EU: 用于具有高工作频率 (> 50MHz) 操作模式的血管内超声成像系统中的电旋转连接器中的汞。



6、 Taiwan - BSMI Published the Operating Requirement for Mandatory Inspection of Children's Raincoats (Apr 14,2015)

台湾-BSMI (台湾经济部标准检验局) 出版了关于儿童雨衣的商品检验作业规定。(2015年4月14日)

On 13 April 2015, the Taiwan Bureau of Standards, Metrology and Inspection (BSMI) has published operating requirements for the mandatory inspection of children's raincoats to provide more detailed information on the areas of drawstring, labeling inspection and commodity inspection under the BSMI Notice no. 10420001610. It becomes effective immediately.

2015年4月13日,台湾经济部标准检验局出版了关于儿童雨衣的商品检验作业规定,在BSMI公告中提供了更多关于拉带,标示检查和商品检验的细节,这个规定即日生效。

- 1) Specified that the cords and drawstrings on hood and neck area of children's raincoats shall comply with the clause 3.1 to 3.3 of CNS 15291.
连颈帽及颈部的绳带和拉带应该依据CNS15291 “儿童衣物安全规范-儿童衣物之绳带及拉带”第3.1至3.3节检验。
- 2) Examples are added to elaborate the term of " Instruction for use, handling precautions and safety warning" for labeling inspection. It including Handling methods after use, storage methods, cleaning instructions, drawstring warning, keep away from fire warning etc shall be shown.

- 3) Details of Monitoring Inspection and Registration of Product Certification (RPC) are mentioned including the requirements of Commodity Inspection Marks : for Monitoring Inspection, code start with "C" or "M", for Registration of Product Certification (PRC), code started with "R". Here are the example of Commodity Inspection Mark :

7、 Ecuador - Proposed Technical Regulation for Protectors for Body Extremities for Sport Activities (Apr 14,2015)

Wrists, hands, elbows and knees protective to users of sports equipment on normal wheels, for the following performance levels:

Knee and elbow protectors for indoor sports, on smooth and flat floors, without mattress, for the following classes of users:

- Class A: Users with body mass of 50 kg;
- Class B: Users with body mass greater than 50 kg;

8、 California/USA – Proposes Prohibition of Sale of Corded Window Coverings. (Apr 15,2015)

美国加利福尼亚州-提出了禁止出售有绳窗帘 (2015年4月15日)

The State of California has a bill (AB 282) introduced to propose an act prohibiting the sale of corded window coverings.

However, if an accessible cord cannot be eliminated from a corded window covering due to large size of the covering or another reason, the covering may be sold only if the cord is made inaccessible through the use of a cord cover or another effective passive guarding device.

Once approved as proposed, the act shall become operative on 1 January 2017

加利福尼亚州AB 282法案提议禁止出售绳状窗帘

如果由于窗帘的尺寸过大或者其他的原因，一根可触及的绳不能被绳状窗帘去除掉的，那么这根可触及的线必须使用不可触及的绳盖或其他有效的被动安全防护装置，此产品才可以售卖。

一旦建议获得批准，会在2017年1月1日实施。

Note\注释

“Accessible cord” means any cord with a length of over 7 ¾ inches, including a cord that can be extended or pulled to exceed 7 ¾ nches.

–“Corded window covering” means a window covering, including, but not limited to, blinds, curtains, draperies, and shades, that has an accessible cord.

9、 Malaysia – Proposes Draft Regulation for Plastic Food Contact Materials and Articles. (Apr 16,2015)

马来西亚- 起草塑料食品容器法规的草案。(2015年4月16日)



The Ministry of Health Malaysia (MoH) has proposed the Draft Food (Amendment) (No.1) Regulations 2015 to amend the Food Regulations 1985. One of the proposed amendments is to add a new Regulation 27B for plastic food contact materials and articles. Here are the highlights:

Scope\范围

Plastic materials and articles include packages, plastic multi-layer or plastic multi-material multi-layer that is:

10、 Japan - Approved to Amend the 'Act on Control of Household Products Containing Harmful Substances' . (Apr 17, 2015)

On 8 April 2015, the Ministry of Health, Labour and Welfare (MHLW) has approved to amend the Article 2 of the "Act on Control of Household Products Containing Harmful Substances" (i.e proposed item I) to designate the proposed 24 aromatic amines as harmful substances. This amendment shall enter into force on 1 April 2016.

2015年4月8日，日本劳动卫生福利部批准有害物质控制法案的第二章修正案，指定24种芳香胺为有害物质，此修正案于2016年4月1日生效。

11、 EU – Draft Commission Regulation amending Annex XVII to REACH (EC) No 1907/2006 on Nonylphenol Ethoxylates. (Apr 21,2015)

A draft Commission Regulation to amend Annex XVII to REACH Regulation (EC) No 1907/2006 as regards nonylphenol ethoxylates (NPE) was published.

欧盟颁布REACH法规(EC) No.1907/2006附录XVII修订草案，对壬基酚乙氧基化物的使用进行限制。

欧盟拟修改REACH法规 (EC) No.1907/2006附录XVII，对壬基酚乙氧基化物含量进行限制。(2015年4月21日)

The new entry 46a is proposed to be added. Nonylphenol ethoxylates, (C₂H₄O)_nC₁₅H₂₄O, shall not be placed on the market from 60 months after the date of entry into force in textile articles which can reasonably be expected to be washed in water during their normal life cycle, in concentrations equal to or greater than 0.01% by weight of the textile article or each part of the textile article. This shall not apply to the placing on the market of second-hand textile articles or to new textile articles produced exclusively from recycled textiles.

作为第46a条，在此法案强制执行的第60个月之后，针对在可预计的情况下，产品生命周期中会被水洗的纺织类产品，若其壬基酚乙氧基化物Nonylphenol ethoxylates, (C₂H₄O)_nC₁₅H₂₄O的含量大于等于其产品重量或者产品部分组件重量的0.01%，则不允许投入市场。该条款不适用于市场上的二手纺织产品或者用可回收纤维制得的新纺织品。

Note\注释

"Textile article" means any unfinished, semi-finished or finished product which is composed of at least 80% textile fibres by weight, or any other product that contains a part which is composed of at least 80% textile fibres by weight.

12、 Oman - Draft Marketing Regulation of Designated Products for Babies and Young Children. (Apr 21,2015)

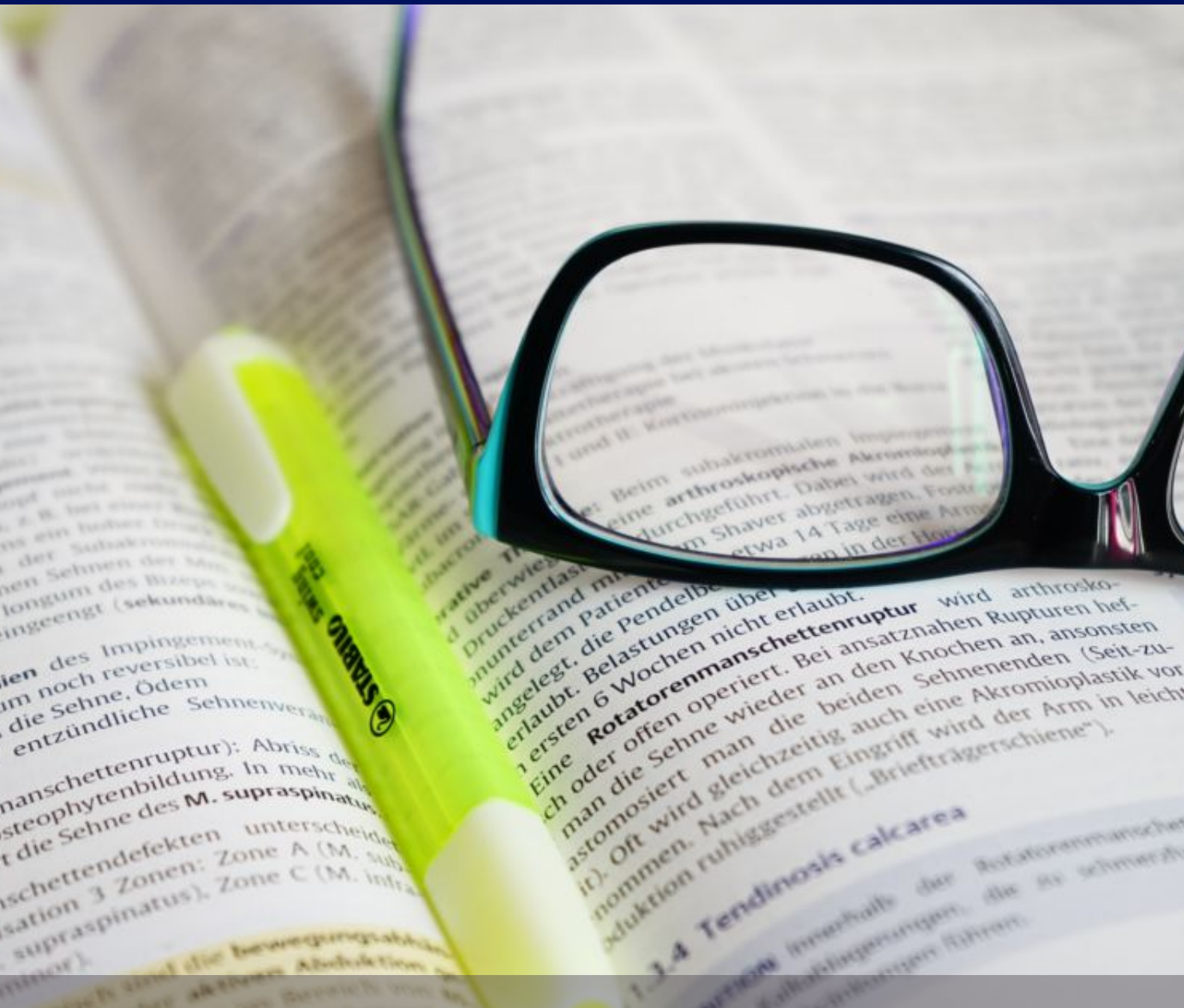

新修订的2014版BSCI行为守则于2014年1月1日生效，将从2015年1月开始实施。

倡议商界遵守社会责任组织（BSCI）是欧洲对外贸易协会（FTA）在2003年发起的一个服务项目，面向所有零售、品牌和进口公司，通过执行统一的社会责任标准改善全球供应链的工作条件。新修订的1/2014版BSCI行为守则于2014年1月1日生效。BSCI将从2015年1月开始依据本守则所订定的原则来监控。因此，根据2009版BSCI守则的审核到2015年1月将不再有效。2014版守则进一步加入了新的原则，例如“无缺乏保障就业”和“道德的商业行为”，新版原则不仅在于履行法律义务，更是长远的强化企业竞争力。



基于FEMA的风险评估
和管理培训

风险控制是质量管理活动的重要组成部分，组织如何做到真正的管理并降低风险？如何真正的预防以及有效的持续改善？FMEA(Failure Mode and Effects Analysis, 失效模式与后果分析) 是产品可靠性分析方法，是一项用于确定、识别、预防或消除产品在系统、设计、过程或服务中已知的和潜在的失效、问题、错误的技术。主要是利用表格方式协助分析原因和影响，对关键过程和质量进行预防性控制和管理，预先采取措施以降低故障风险的产品质量保证方法。在ISO/TS16949, BRC和SQP等质量体系标准中提出组织需要掌握及理解FMEA并有效应用，以提高质量管理控制能力。风险思维是一种专门用来处理风险和不确定性的思维方式。本课程说明了“风险商”在制造业中风险管理的重要性究竟有多大。
